Approx. 20 trees down in sinkhole in last 3 days, Skimming and Cleaning continues. Setting up rig to drill out Geophone Well #1. Bubbling in pond north of Tx Brine Vent Wells. Shaw and Labarre (rep.) sampled Hooker #1 well. Flowed Oxy 3-A Before flowing SITP 101psi, SICP 588psi, After Flowing SITP 102psi, SICP 400psi, Brine in 32.64bbbls, Oil out 17.7bbbls, Gas out 4.4mcf. Logged Oxy 3-A, sent logs with Darryl Williams to BR. Tx Brine Vent Well #1 FTP 2.5psi, 54.5mcf. Tx Brine Vent Well #2 S/I 24hrs. gas was sampled from well by Shaw and Code Red.)RW #1 FTP 15psi, Gas Vol. 23.56 mcf, 12/64 choke. ORW #2 FTP 52psi, Gas vol. 31.98, 9/64 choke. ORW #3 SITP 0psi. ORW #4 FTP 21psi. Gas Vol. 6.7mcf, 6/64 choke.
