## **JUDGMENT**

The Court enters the following judgment:

In accordance with the jury finding that BP Products North America, Inc., BP Exploration & Oil, Inc., BP Exploration, Inc., and Sohio Petroleum Company (collectively "BP") are responsible for environmental damage on property owned by plaintiff, The Sweet Lake Land and Oil Company, LLC ("Sweet Lake"), in Section 34, Township 10 South, Range 6 West, Calcasieu Parish, Louisiana (the "Property"), the Court HEREBY ORDERS BP to submit a plan to remediate the Property to the Department of Natural Resources, Office of Conservation (the "department"), this Court, and Sweet Lake within 60 days of this order. The plan shall remediate to applicable regulatory standards the contamination that resulted in the environmental damage to the Property. It is further ordered that Sweet Lake shall have 60 days from its actual receipt of BP's submittal

Sweet Lake's claims against AKSM, L.C., Oleum Operating Company, and Flash Oil and Gas Northeast, Inc. are hereby dismissed with prejudice. Sweet Lake's claims for money damages against BP are hereby dismissed with prejudice.
