**LOCATION:** Saint Bernard Parish, LA; Approximately 14 miles East-Southeasterly of Hopedale, LA;

Blocks 47 & 72, Chandeleur Sound Area; Half Moon Lake Field. Sections 18 & 19; T15S-R18E. Flowline POB: Lat. 29° 44′ 07"N, Long. 89° 26′ 07"W; POE: Lat. 29° 45′

**DESCRIPTION:** Proposed installation of a 4" flowline (7,541') for SL 16158 Well No. 2. The pipeline will

be laid on top of the ground on land by utilizing push/pull method. No tracked or wheeled equipment will be utilized on the marsh. Erosion control material will be used at the land/water interface. Approximately 2,930 cubic yards of material will be displaced by jetting. An additional 20 cubic yards of erosion control material will be required for the two (2) water/land interfaces and 5 cubic yards of sandbag material will be utilized to

reinforce pipeline crossings.
