

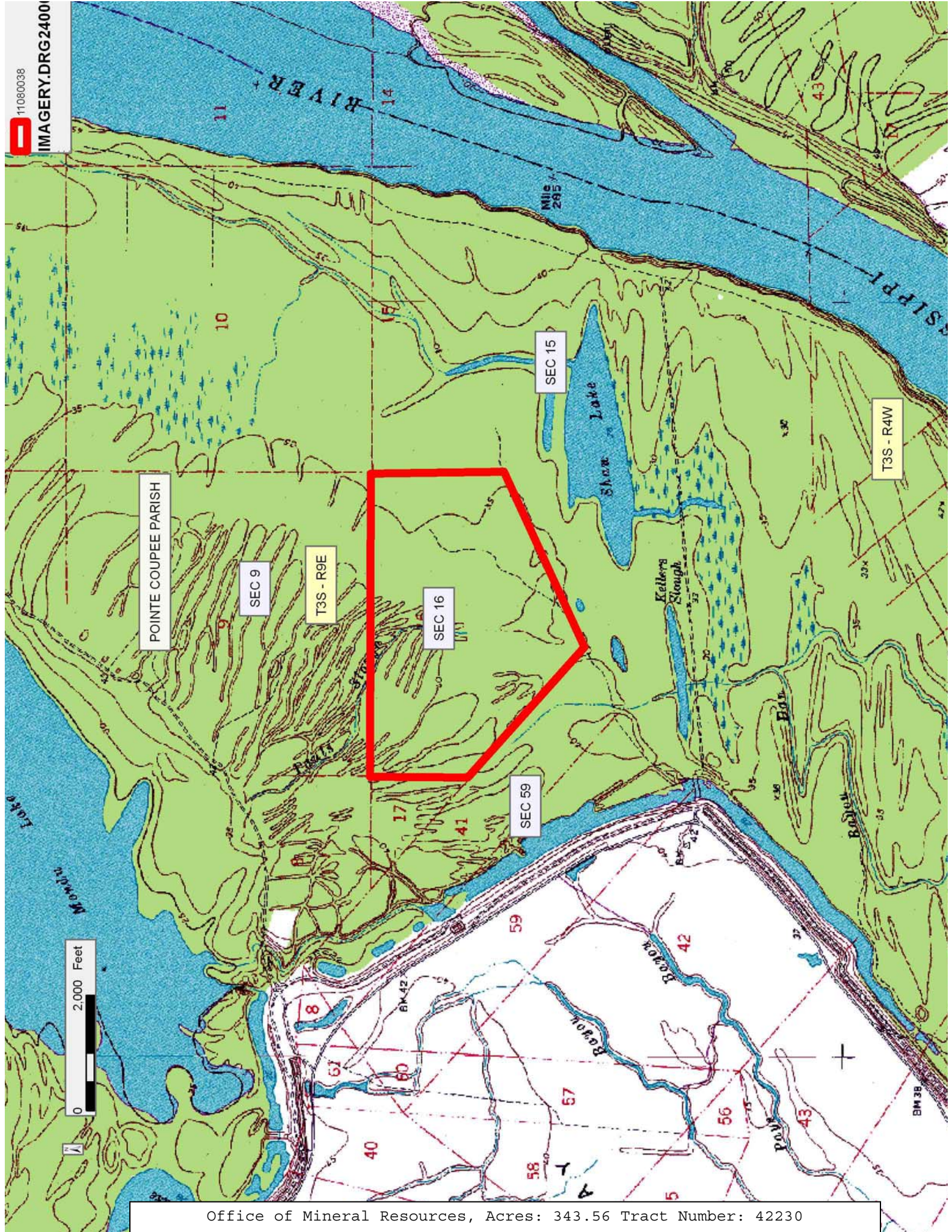
TRACT 42230 - Pointe Coupee Parish School Board - Pointe Coupee Parish, Louisiana

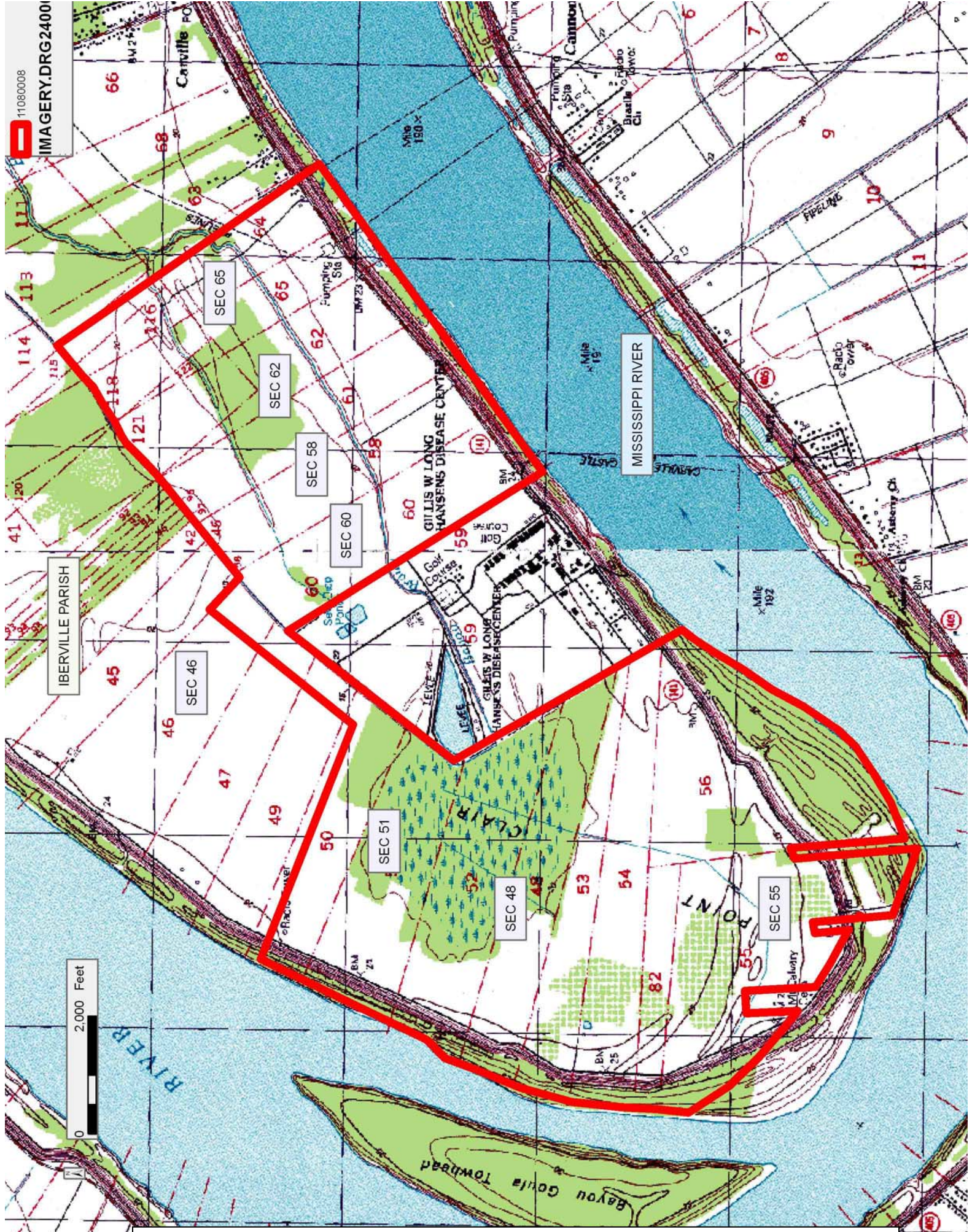
