In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY**, **JUNE 23**, **2009**, upon the application of **GINGER OIL COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Formation**, **Reservoir A**, in the Oaks Field, Claiborne Parish, Louisiana.

- 1. To create eleven (11) additional drilling and production units for the exploration for and production of gas and condensate from the Haynesville Formation, Reservoir A.
- 2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed units, with each tract sharing in unit production on a surface acreage basis of participation.
- 3. To designate a unit well for each of the proposed units, if appropriate.
- 4. To designate Ginger Oil Company as the operator of each of the proposed units, if appropriate.
- 5. That with respect to future horizontal wells drilled to the Haynesville Formation, Reservoir A, in the proposed units, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Formation, Reservoir A, the distance to any unit boundary and any offset well(s) should be calculated based on the distance to the nearest perforation in the well and not based on the penetration point or terminus.
- 6. To extend to the proposed units, to the extent not inconsistent herewith, all pertinent provisions of Office of Conservation Order No. 888-D, effective January 1, 1978, and all applicable Statewide Orders.
- 7. To consider such other matters as may be pertinent.

The Haynesville Formation, Reservoir A was fully defined in Order No. 888-D, effective January 1, 1978. A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
